

Wise Up! Summer Program 7th Annual Internship Deadline: May 13th, 2016



Since 2001, Wise Up! – a project of CHIRLA – has been the foundation of immigrant youth organizing in Los Angeles and across the state of California. Wise Up! was created when immigrant students began organizing and advocating for the passage of AB540 – a California bill that allows students to pay in-state tuition regardless of their immigration status. Twelve years later, Wise Up! continues to be one of the few high school student-led groups focused on immigrant rights. Wise Up! strives to work on promoting higher education amongst undocumented and immigrant students, as well as other issues that affect the immigrant community. In 2012, CHIRLA'S Wise Up! was honored with the 2012 Latino Heritage Award by Los Angeles Mayor, Antonio Villaraigosa primarily for the work Wise Up! students put in that year to educate over 3,000 students, parents, counselors, and educators on issues such as AB 540, the California Dream Act, and Deferred Action.

Wise Up!'s Summer Program is a **six week non-paid internship** where high school students with a strong desire to get involved in their community will have the opportunity to learn about organizing and advocating for immigrant rights. In addition to personal and professional development, by the end of the program, interns will have a grasp on organizing basics, event planning, and benefit from peer college counseling. Students will also take part in CHIRLA and Wise Up!'s general activities and actions. The Summer Program will culminate with a Northern California College Tour Trip where we will visit five to six colleges/universities.

Program Calendar:

- May 13th, 2016: Applications must be post-marked or delivered in person by May 13th, 2016 to be considered for the internship.
- May 27th, 2016: Potential accepted interns will be contacted by phone.
- > June 8th, 2016: Mandatory Student and Parent Orientation at 6pm.
- Summer Program Schedule: June 21st -July 21st, 2016
 - Tuesdays: 10am 4pm
 - Wednesdays: 12pm 6pm
 - Thursdays: 10am 4pm
- Northern CA College Tour Trip: Week of July 25th- 28th (3-4 days)

Eligibility Criteria:

- Must be a high school student in Los Angeles County.
- Must be a high school student.
- Must come from an immigrant family.
- Must demonstrate interest in participating and/or becoming active on immigrant rights issues and/or other progressive social justice causes (in school or local community).
- Student must commit to full program calendar.
- Must attend student and parent orientation on June 9th at 6pm at the CHIRLA office.

Summer Program Activities:

- Interns will receive professional development workshops such as Public Speaking, and writing a Resume.
- Interns will participate in Organizing 101 workshops to learn and comprehend who is an organizer as well as practice using their organizing skills.
- Interns will write/review a college application essays/prompts; receive other college-bound workshops.
- Interns will receive hands-on fundraising experience by fundraising for the Northern CA College Tour (this will benefit the student in the near future since they will learn tactics to fund their own education).
- Interns will participate in CHIRLA's general organizing activities and events that are in and outside of the offices.

Application Materials:

- □ Wise Up! Summer Program Application Please complete application in full.
- □ One Short Written Prompt:
 - 1. ONE (1) Personal Statement (400 words maximum) Include the following:
 - Describe your background family, financial, academic, and community
 - What drives you to be involved in immigrant or immigrant student issues? Give examples of community involvement you have done or would like to do.
- □ **High School Transcripts -** Submit most current high school transcripts. You may submit an unofficial or official transcript.

Application Instructions:

- 1. Send only application materials listed above.
- 2. Prompt must be typed with a one-inch margin and double-spaced. Font must be Times New Roman and Size 12.
- 3. Everything must be mailed together in the following order:
 - a) Summer Program Application (*In front of all documents*)
 - b) Written Prompt
 - c) Transcripts
- 4. Application must be postmarked, delivered in person, or faxed **by May 13th** to the address below.
- 5. Emailed applications will **not** be accepted
- 6. Incomplete applications will **not** be reviewed. Applications missing any of the required documents are considered incomplete.
- 7. Selected participants will be notified by Friday May 27th, 2016
- 8. Regret letters will not be sent.
