Summary

The Counselor I will be responsible for providing direct program implementation activities as part of an innovative substance abuse program under the administrative supervision of the Division Director and clinically supervised by the Clinical Supervisor. Responsibilities include development of community contacts, outreach & recruitment, conducting participant screenings and assessments, facilitating individual and group level counseling sessions with participants, and tracking participant progress. The Counselor I will have clear professional guidelines about how to successfully work with substance abuse client population. The Counselor I must provide culturally competent services to diverse ethnic and cultural communities including, but not limited to the following target populations: people of color, gay/lesbian/ bisexual/ transgender/questioning community, monolingual and/or undocumented immigrants, substance users, and homeless persons, of varying ages. This is a full-time position and will require flexible hours including evenings, weekends, and some holidays.

Essential Functions

- 1. Conduct individual and group level counseling sessions in accordance with the Seeking Safety curriculum under the supervision of the licensed Clinical Supervisor.
- 2. Conduct client screenings and assessment plans.
- 3. Establish and maintain connections with Los Angeles based substance abuse treatment programs.
- 4. Develop and implement outreach recruitment and linkage referrals to community wide stakeholders.
- 5. Implement programmatic scope of work at a minimum of 85% completion rate.
- 6. Report on intervention activities and propose strategies to address challenges in implementation and emerging trends.
- 7. Provide necessary programmatic documentation, including the timely completion of reports, administration of evaluation tools, and other program related assignments.
- 8. Attend unit, case conferences, agency, community events and link with other substance abuse prevention programs in Los Angeles County
- 9. Other activities as required to conduct program and agency objectives.

Minimum Qualifications - Knowledge, Skills and Abilities Required

- 1. Licensed, registered or eligible MSW, MFTI, Psychology Assistant or equivalent; and/or current Certified Addiction Specialist (CAS) certification or equivalent.
- 2. Current license with the California Board of Behavioral Sciences (for MSW/MFTI level candidates) and/or the California Association of Alcoholism and Drug Abuse Counselors (for CAS level candidates).
- 3. Intermediate knowledge of HIV/AIDS, substance use, and correlated health issues.
- 4. Ability to competently conduct trainings and workshops.
- 5. Ability to coordinate multiple tasks simultaneously in high pressure environment.
- 6. Fluent in an Asian language or Spanish (read, speak, write).
- 7. Reliable transportation.
- 8. Valid California Driver's License, plus proof current automobile insurance.
- 9. Proof of employment eligibility.
- 10. Updated tuberculosis test (annual requirement) read, reviewed and dated by a clinician.
- 11. Ability to master a wide range of information, taking initiative and adapt in a team environment
- 12. Ability to communicate effectively both verbally and in writing
- 13. Ability to work with diverse communities (e.g. multi-gender, ethnic, generation, lingual, Lesbian, gay, bisexual, and transgender, and substance users).
- 14. Good problem solving and conflict resolution skills.
- 15. Great attitude and people skills a must.
- 16. Experience and knowledge of PC hardware and software (Outlook, Windows, Power Point, Word and Excel a must).

Non-Essential Qualifications - Knowledge, Skills and Abilities

- 1. Completion of the Seeking Safety intervention training.
- 2. Relevant community health education training.
- 3. Experience working in a non-profit community based organization.
- 4. Knowledge of behavior change interventions.

Supervisory Responsibilities
