ABOUT NAPAWF

The National Asian Pacific American Women's Forum is the only national, multi-issue Asian and Pacific Islander (AAPI) women's advocacy organization in the United States. We are building a movement to advance social justice and human rights for AAPI women and girls in the U.S. We implement our vision by increasing the leadership, power and visibility of AAPI women and girls through five strategies: grassroots organizing and leadership building; community based research; policy advocacy; and strategic collaborations. Founded in 1996, we are a growing and dynamic organization with staff in three offices and local chapters in sixteen cities.

POSITION OVERVIEW

This position is a significant leadership position for a multi-talented professional who is passionate about movement building, policy advocacy, reproductive justice, and AAPI women and girls. The Reproductive Justice Program Director will serve as the lead voice and expert on reproductive justice issues impacting the lives and well-being of AAPI women and girls.

POSITION SUMMARY

The Reproductive Justice Program Director, who is based in Washington, D.C. and reports to the Deputy Director of Programs and Policy, is responsible for leading NAPAWF's reproductive justice program. Specifically, the Reproductive Justice Program Director is responsible for:

- Educating legislative, administrative, and community decision makers on reproductive justice policy issues affecting AAPI women and girls through meetings, policy briefings, and fact sheets/policy briefs
- Spearheading assigned coalitional efforts, including but not limited to NCAPA,
 CAARE and others; and working in coalition with numerous civil rights, civil

- liberties, women's, religious, reproductive rights, racial/ethnic, professional, and immigration groups around the country
- Developing and implementing reproductive justice campaigns impacting AAPI women and girls nationally and locally, which includes NAPAWF's current national campaign on fighting back on sex-selective abortion legislations
- Tracking federal and relevant state bills and organizing educational opportunities for policy makers, allies, and NAPAWF's leaders/constituents that include briefings, webinars, conference presentations and other high-profile events
- Building the capacity of NAPAWF chapters to do local/state/national advocacy work
- Assist the Executive Director and the Deputy Director of Programs and Policy with outreach and managing relationships with reproductive justice funders
- Developing, with communications staff, draft press releases, fact sheets and op-ed articles for distribution to members and general public
- Overseeing the implementation of NAPAWF's new reproductive justice leadership development program, RJ LAMP (Reproductive Leadership Amplification Program)
- Supervising the LSRJ Fellow, program staff and interns
- Performing duties, as necessary, as a member of the NAPAWF team

QUALIFICATIONS:

We're seeking candidates who excel in relationship building, are results oriented, and have strong project management skills. You should have:

- A Master's Degree, Bachelor's degree or equivalent work experience.
- A demonstrated commitment to meeting a high bar and a history of getting things done even in the face of obstacles.
- A high-level, strategic understanding of social change and progressive movements backed by direct experience with grassroots efforts.
- In-depth knowledge of reproductive justice issues and AAPI women's issues and strong existing relationships with reproductive rights, reproductive health and reproductive justice organizations, AAPI organizations, policy makers and other national policy organizations.
- Past successes designing and leading policy advocacy initiatives on a local, state and/or national level.
- Be an excellent communicator and writer with experience as a spokesperson who can articulate messages to different audiences.
- A track record of developing and maintaining strong working relationships with and among a diverse group of stakeholders.
- Experience managing multiple projects and ability to work flexible hours and travel.
