### Background:

Nan-Hui Jo is a devoted mother, undocumented Korean, and survivor of domestic violence. After fleeing to Korea with her child to escape her abusive partner, Nan-Hui was charged with "child abduction" and was placed in jail for over nine month without bail. Her six-year-old daughter was given custody to the child's father. Following her conviction on charges of "child abduction," Nan-Hui Jo was immediately taken into Immigration and Customs Enforcement (ICE) custody. She faced indefinite detention and/or deportation, and possibly a permanent separation from her daughter. However, on Friday, July 17th she was released on bond, due to the strong community support that organized for her release.

We celebrate Nan-Hui's release from jail as an incredible, critical victory following nearly one year of incarceration. We know, however, that the struggle is not over. Despite her release from detention, she is still fighting deportation in upcoming immigration hearings. She is still challenging her unjust criminal conviction for child abduction, which resulted from the actions she had taken to protect herself and her child. She still needs to rebuild her relationship with her daughter, who has not seen her mother for a year.
